VIII. OTHER ITEMS OF IMPORTANCE

- Sandy mentioned that Rep. Curt VanderWall reintroduced versions of Sen Shirkey's legislation (SN597 & 598) from last year and that there were companion bills emerging in the House, HB4576 & HB 4577. These bills appear to be similar to the version of the bills that were up during lame duck. HB 4576 essentially carves in all of kids services to the health plans and then creates one new statewide managing entity for everything else (including GF). HB 4577 brings back the idea of creating an office of the behavioral health ombudsman. CMHA is monitoring any movement on these bills.
- Sandy mentioned that she emailed Comm Christopher Boyd about the board vacancy left by Andrea Schrems and that she was looking for a replacement candidate to recommend to Comm. Boyd with lived SUD experience.
- Sandy mentioned that MDHHS staff will be coming to SCCMHA next week, Wed., May 31 for a CCBHC Site visit.
