III. INDIVIDUAL PLACEMENT AND SUPPORT (IPS)

John Burages, Director of Services for Persons with Mental Illness reviewed a PowerPoint on the Individual Placement and Support or IPS (the EBP for Employment). The following was noted:

- IPS is Effective in a Wide Variety of Target Populations such as PTSD diagnosis, mental illness + substance abuse, older adults, first episode of psychosis, homeless, criminal justice history, disability beneficiaries & various racial and ethnic groups)
- SCCMHA is just starting up this EBP at SCCMHA.
- Why should we focus on employment and careers?
 - Considered by many as an important part of recovery
 - Most people with serious emotional illness want to work
 - Employment is a typical role for adults in our society
 - Cost-effective alternative to day treatment
- Benefits of Steady Competitive Employment?
 - Increased income
 - Improved self esteem
 - Improved social networks
 - Increased quality of life
 - Better control of symptoms
 - Reduced hospitalizations
 - Reduced substance use
 - Reduced used of mental health services
- Negative Effects of Unemployment in General Population?
 - Increased substance abuse
 - Increased physical problems
 - o Increased psychiatric disorders
 - o Reduced self esteem
 - Loss of social contacts
 - Alienation and apathy
- Principles of IPS

- Open to anyone who want to work
- o Focus on competitive employment
- Rapid job search
- Targeted job development
- o Client preferences guide decisions
- o Individualized long-term supports
- Integrated with treatment
- Benefits counseling included
- Track Process and Outcomes

 - People with serious mental illness do want to work and can work in integrated competitive employment
 - o IPS is a successful employment intervention for a wide variety of populations
 - ISP is an evidence-based practice that includes program manuals and an IPS Fidelity Scale to serve as roadmaps for good program implementation
 - Agency leaders organized services, maximize funding, provide training and supervision, monitor implementation and track outcomes to ensure highquality IPS services
- Supported Employment Fidelity Scale from SAMHSA

IV. TECHNICAL REQUIREMENTS FOR SED CHILDREN FROM MDHHS CONTRACT

Erin Nostrandt, Director of Children's Services reviewed a PowerPoint on Technical Requirements for SED Children from MDHHS Contract. The following was noted:

- Scope:
 - Provides Medicaid eligible criteria for children with Serious Emotional Disturbances (SED)
 - Establishes General Fund priority for mental health services for children with SED
- General Considerations:
 - Provides a framework to be used by Community Mental Health Services
 Programs (CMHSPs) for establishing General Fund priority for mental health services for children with Serious Emotional Disturbance (SED)
 - Diagnosis alone is not sufficient to determine eligibility for General Fund priority and should be coupled with functional impairment and duration criteria
 - Framework is intended to:
 - Assist CMHSPs in determining severity, complexity, and duration
 - Bring uniformity to these decisions for children across systems
- Detailed eligibility criteria, including crosswalk tables, as part of the Contract Attachment C4.7.2 can be further referenced
- Criteria of SED 7-17 Years
- Criteria of SED 4-6 Years
- Criteria of SED Birth-3 Years
