IV. CERTIFIED COMMUNITY BEHAVIORAL HEALTH CLINICS (CCBHC) ADVISORY COUNCIL – UPDATE [NOV / FEB / MAY / AUG]

Colleen Sproul, Director of Health Home, Integrated Care and Care Management presented SCCMHA CCBHC Year One Progress Toward Annual Goals 4/20/21. See document for details.

- Just completed our first year for CCBHC (April 30, 2021)
- Enrolled 177 adults (goal of 178) and 49 children (goal of 37)
- Four (4) Measurements

- By the end of the last quarter, the number of organizations collaborating as a result of the grant was 3: Great Lakes, Bay Health Centers, Quest Diagnostic, and Covenant, Visiting Nurse Association (38%).
- The number of individuals screened for mental health or related interventions was 3,014 (164%).
- The number of people in the workforce who were trained on practices consistent with goals of the grant was 825 (138%).
- The number of consumers or family members (secondary consumers) on advisory councils was 29 out of a total goal of 15*: 5 on SCCMHA Citizens Advisory Committee, 4 on SCCMHA Board of Directors, and 20 on Consumer Leadership Group (193%).
- State of Michigan will be rolling out demonstration CCBHC (SCCMHA was made eligible for this also)

Motion made by Lyn Bradfield and supported by Deb Nagel to receive and file the Quarterly CCBHC Advisory Body Report as presented. Motion Carried.

V. REVIEW OF CITIZENS ADVISORY COMMITTEE TO SCCMHA BOARD POLICY – 01.01.05

A. MSHN Citizen's Advisory Council Update

Deb reported: Lifeways implementing hospital diversion program (up to 24 hours) to reduce crisis visits and inpatient hospitalizations.

Sandy noted that SCCMHA is working with GLBHC to do a community vaccination clinic for consumers served by SCCMHA living independently. There also continue to be staffing shortages in MSHN CMH networks related to COVID-19 pandemic (importance of maintaining fair wages and necessary training for direct care workforce).

IX. CEO REPORT – SANDRA LINDSEY

'Gearing Toward Integration' Redesign Plan / CMHA Advocacy Against the Redesign Legislative changes are being proposed to tie financing to integration in FY 22 budget. Would take CMH system under the control of Medicaid insurance companies as providers (for both physical and mental health care). This would be a carve in and would eliminate PIHP's public governance. CMHSPs would not be the only managers. PIHP and CMHSP system is opposed to these proposed changes. CMHAM advocacy has begun also. Action alert was shared with SCCMHA Board and CAC either late last week or early this week.

Another proposal on the House side as well (Mary Whiteford). CMHAM has not stated their stance on proposal as they are in negotiations with her office. The only way to stop recommended changes is by Governor's veto (as republicans hold both House and Senate). Action alerts will continue to be shared with SCCMHA Board and CAC.
