VI. CEO REPORT

Update on Extended Hours Pilot

Sandy noted that there have been clinical productivity concerns for a couple of years now and our work this past winter to put specific standards this past winter were interrupted by the onset of COVID-19. Now that staff are almost all back in the office, they need to once again be put in place. Sandy talked with staff over several Skype calls about potentially moving all staff from salary to hourly arrangement to address attendance and accountability as well as productivity for clinical staff (billable events). After much administrative discussion, SCCMHA has decided to postpone this change agency wide. Instead the plan is to move to increased clinical service delivery by the Board Operated Program with a combination of extended hours and clocking in and out of the ADP payroll system using new remote functionality, without any changes to the salary compensation architecture. These changes, framed as a pilot, will be exclusive to clinical operations and related front desk and security functions. The pilot will commence on November 2nd and run through at least February. The pilot goals will feature increased productivity standards, schedule accountability and safety/liability considerations. All of the pilot changes are allowable under the current collective bargaining agreements. The summary of time changes being proposed are as follows:

X. OTHER ITEMS OF INTEREST

State Hospitals are full and the waitlists hundreds of persons long. Because of the need to move people in county jails to the Forensic Center for evaluations and in response to the wait list for admissions to state facilities, MDHHS is starting a Direct Community Placement Program (DCPP). This program is developed to support direct placement discharges by MDHHS of up to 100 persons. MDHHS will be contracting directly with Hope Network and Beason Specialized Residential programs across the state for these beds. CMHSP consumers that may be involved in such discharges will not be charges for the cost of care there.

Sandy also noted that local Emergency Departments are being inundated by kids from Child Caring Institutions across the state. In out region youth are coming to the ED from Wolverine and Holy Cross. These youth often do not meet clinical in-patient admission standards but are being abandoned in the ED by CCIs indicating they can no longer meet the needs of the youth in their facility. This is greatly adding to the problem of ED Boarding. We are in a state of crisis as there are not enough hospital beds for such youth presenting and we cannot solve this problem on our own.
