#### I. CALL TO ORDER

#### II. MENTAL HEALTH FIRST AID TRAINING UPDATE

Jennifer Keilitz presented the Mental Health First Aid Training Update for the Citizens Advisory Committee. The following was reviewed:

#### What's Wrong?

- From 1999 to 2016, 630,000 people died from drug overdose. -Centers for Disease Control and prevention
- Nearly 1 in 5 U.S. adults lives with a Mental Illness. National Institute of Mental Health via the National Survey on Drug Use and Health and the Substance Abuse and Mental Health Services Administration
- On average, 123 people die by suicide each day. American Foundation for Suicide Prevention
- 64.1% of youth with major depression do not receive any mental health treatment. Mental Health America
- 1 in 5 teens and young adults lives with a mental health condition. National Alliance for Mental Illness
- 5.13% of youth report having a substance use or alcohol problem. Mental Health America

Mental Health First Aid is the initial help offered to a person developing a mental health or substance use problem or experiencing a mental health crisis. The first aid is given until appropriate treatment and support are received or until the crisis resolves.

#### VII. CEO REPORT – SANDRA LINDSEY

Action Alerts have gone out asking for participation in automatic way to communicate with your legislature about proposed changes to CMH System (Sen. Shirkey's 'Geared for Change' & Rep. Mary Whiteford's plan). There are hearings for changes proposed by Whiteford. All members of these committees where this legislation is being proposed / discussed to not include members from the Saginaw area unfortunately. Pretty much goes along party lines. Sandy has reached out to our legislators and communicated our belief that these plans are not in the public's best interest or the CMH system as a whole.

Sandy noted that the Director of MDHHS has not been approached by either of authors of these plans (Shirkey or Whiteford). Governor Whitmer has the ability to veto these pieces of legislation but Sandy fear she may not do so as she has other areas that she may be bargaining with Senate and House Republicans and fears we could potentially be

used as a bargaining tool. We'll see how this plays out. Stay tuned as Sandy will continue to forward along requests for action.

Working on SCCMHA Annual Progress Report. Must report to Saginaw County BOC by July 31, 2021. Aim is to memorialize work during COVID-19 pandemic and will include 2020 data, arts and charts focus on what we did to protect consumers and our network.

Workforce shortages everywhere. People are leaving the business and / or are just moving around.

Meeting with key informant to discuss race and culture issues. Changes to Core values, new Workgroup on Cultural Competency as well. Engaging Dr. Paul Elam to assist on this topic. Focus groups and climate assessment on race and culture (develop a workforce more representative of our counties demographics).

Pleased to say that for all of the busy activities going on a the Covenant ED department. There is more Psychiatry there than there has been in a really long time (Psych fellows from CMU Medical Center.

CrisisConnect program with local law enforcement. Data about mental health interface with law enforcement in Saginaw County. Rolling out first to Saginaw City Police later on this summer. iPads will be placed in every patrol car in City. Build out Mobile Response Services team, deployed out of Hancock and have staff available to law enforcement 24/7. Next will be Saginaw Township, followed by BV, and lastly Saginaw County Sheriff's department. Hopeful for police to get good advise out in the field and result in potentially less visits to Emergency Department and/or inpatient hospitalizations. There will be more news upcoming on this project.

New CMH Board member, Cathy Dwan left recently so BOC had to reappoint her seat. Cym Winiecke has been chosen to represent District 1. Orientation with her is scheduled for June 11. She is hopeful that she'll be sworn in at 6/14 Board meeting.
