Motion made by Larry Jones with support from Andrea Schrems to recommend to SCCMHA Admin to put topic of "Board Technology Discussion" on each of the SCCMHA Committee Meetings in June and ask members if there is a way to assist with technology. Motion carried.

V. RELIAS TRAINING AVAILABLE

- Mental Health First Aid Training is also another excellent training. It is an eight-hour training and has been offered in 4 hour time blocks. We could potentially offer a retreat and have MHFA Board training made available or we can perhaps. We need to check with Alecia Schabel, Continuing Ed. Supervisor, to see if it could be offered in smaller time intervals. Sandy will connect with Alecia to see what is possible.
