V. OTHER ITEMS OF IMPORTANCE

Sandy noted that a video is being produced relating to Involuntary and Civil Commitments – a highly technical endeavor that is about an hour in length. Several community partners are in the video (Covenant ED, Prosecutor's office, Probate Judge, SCCMHA Crisis Staff, etc.). The video will be ready for distribution soon (on SCCMHA website likely). Funded by an MDHHS block grant submitted by SCCMHA. A potential Board training perhaps as well.

Laura Argyle is working on Preliminary Budget for FY 2022. It is extremely complicated due to the new Standard Cost Allocation (SCA) processes that are beginning on October 1, 2021. To be discussed at Executive Limitations later this week.

We have a new Auditing firm for SCCMHA for Financial, Compliance and Single Audit for FY 21. The firm was selected through our procurement process (Yeo & Yeo).

Sandy reported that the \$1000 COVID Recognition and Retention payments were sent out last week to SCCMHA staff. Feedback from recipient staff has been positive.

Current arrangement of enhanced premium payments for direct care is set to expire on 9/30/21. There has been discussion among the 12 CMHSP CEOs at MSHN to potentially extend for a period of time, but this is not yet been officially decided.

Staffing and workforce shortages everywhere around the state and SCCMHA is no exception. SCCMHA continues to fill vacancies but as we have many new staff, there will need to be significant orientation and training to help them join the "public" system and understand our specialty benefit and related public policies.

SCCMHA senior staff and colleagues at Covenant ECC, St. Mary's ECC, Health Source Saginaw and CMU are hoping to meet again in October on the Inpatient Hospitalization concerns in our area.

Laura Argyle is presenting at Saginaw BOC's Audit/Budget Committee early next month about the positive FY 2020 SCCMHA Financial Audit.
