• CCBHC Demo Certification Submission to MDHHS

SCCMHA unable to submit by deadline in October due to all the work that needed to be completed for Billing Coding changes from State of Michigan. This task has now been accomplished and SCCMHA is now moving to CCBHC certification using new CRM Portal where State of Michigan is requiring submission for all certification documentation going forward. Hopeful to have this completed by December 4. Could then begin demo and prospective payment structure for enrolled consumers in CCBHC in January.

• System Redesign Update

Agrees with Mr. Bryant's earlier comments on Senate Bills being proposed by Michigan Republican leadership. There have been some amendments already to these bills which made them even worse (proposed PIHP structure eliminated and CMHSPs 'may' be contracted with but not a requirement by Special Identified Plans (SIPs) that have never delivered services to consumers served by CMHs. Last month it was amended about Social Welfare Act (newly appointed advisory Board would be appointed and historic safety net rules for CMHs would be removed / failed to exist as there would no longer be funding - specifically Community Engagement activities). Two documents from CMHA "Dangerous, Costly..." & Within Our Reach". Sandy noted she feels SCCMHA staff and provider networks are doing a standup job serving our consumers.

Meeting today about Discharges from State Facilities and the current environment making this very difficult.

Changes to NGRI planning as well (Risk Mitigation Strategies, etc.) but with current staffing shortages this is very difficult to navigate as well.

• Workforce Shortages

Doing everything we can to post/recruit for vacant positions. Note: Negotiations with all three unions continue.

• Federal Vaccine Mandate

The standards have been released from OSHA and CMS (but SCCMHA is still waiting on MIOSHA's interpretive guidance). Sandy knows this mandate could be upsetting for staff so SCCMHA is being cautious with the deadline of January 8 quickly approaching. SCCMHA has engaged legal counsel from Braun Kendrick to assist with research on both federal mandates. Sandy notes SCCMHA is not rushing into this especially with legal challenges underway for both mandates. Larger residential providers are especially cautious, and this could drive individuals from direct care employment. Stay tuned. Additional info will be communicated once it is available.

Attended NGRI breakout session and felt these changes were very confusing (this coming from someone working in corrections/law enforcement). PowerPoint on Page 11 - 40.

Mike noted it was nice to be in person again and appreciated.

Larry noted that labor shortages noted across the state and being very concerning (effectiveness of agency with this going on is a major concern). There is a lot of uncertainty, and the current political climate right now is not helping either. He hopes to have virtual conference option into the future as well (ability to participate if not comfortable with in person option as of yet).

With regard to SB on System Redesign: Phone calls to legislators is so very important (lighting up the phones is very much necessary to push folks that are non-committal). Email action Alerts via CMHA continue but please remember phone calls to local legislators are extremely important.
