#### I. OPENING PROCEDURE

Larry Jones, called the meeting to order at 5:18 p.m. Verification of the public posting was acknowledged and a quorum was established.

# III. UPDATE ON REMOTE MEETINGS UNDER LOCAL STATE OF EMERGENCY THROUGH AUGUST 31, 2021

Ryan briefly noted that the language in SB 1246 that allowed for remote meetings for any reason expired on 3/31/21 but on 4/1/21 Saginaw County initially declared a temporary Local State of emergency (7 days) and extended by formal resolution at their 4/8/21 Special Board of Commissioners meeting. This declaration allows for virtual public meetings as long as this Local State of Emergency stays in effect, in this case until 8/31/21. SCCMHA will continue to hold our meetings using Zoom conference which allows for both video/audio and only audio by telephone. See pages 3 – 4 in tonight's packet for details.

Motion made by Mike Cierzniewski with support from Steve Fresorger to receive and file Update on Remote Meetings Under Local State of Emergency Through 3/31/21. Motion carried.

## IV. EXAMINATION AND DISCUSSION ON PROCESS FOR MONITORING BOARD ATTENDANCE FOR EARLIER INTERVENTIONS
