Colleen Sproul, Chief of Health Services & Utilization Management presented on CCBHC-E (Expansion) Grant. The following was noted:

 - S1: The number of individuals who have been screened for mental health or related interventions is 6,275.
 - WD2: The number of people in the workforce who have been trained on practices consistent with goals of the grant is 1,611.
 - PC2: The number of organizations reported to be collaborating as a result of the grant is 17: Ascension, Covenant Health System, Covenant Visiting Nurse Association, two organizations with the DECIPHeR Initiative, the Department of Veterans Affairs, Ezekiel Project, Great Lakes Bay Health Centers, Quest Diagnostic, Saginaw Community Health Improvement Plan-Behavioral Health Action Team, 5 local prescribers in collaboration

VII. CEO REPORT – SANDRA LINDSEY

COVID-19 cases had doubled in residential settings since Christmas which is concerning. Saginaw County Public Health cases were up overall as well. Hopeful that the trajectory is now going down (with OMICRON becoming the most prevalent variant and appearing Citizens Advisory Committee Meeting Minutes February 3, 2022 Page 4 of 4

to be running its course). Sandy also reported the COVID-19 Vaccine mandate was struck down by Supreme Court for businesses with greater than 100 employees. The CMS mandate for providers of Medicaid / Medicare is still in place and appears to have an impact on approximately 20 SCCMHA staff and contract providers in certain job classifications.

State's actuary Milliman has forwarded a description of Salary Survey to be completed by CMHSP / PIHP provider networks (notification went out yesterday to SCCMHA providers). Hopeful that this goes well but Sandy noted she knows that this is a big lift. This info is being used to evaluate expenses across the state with the intention of getting to a standard fee schedule across the state.

All three of SCCMHA's union contracts that were set to expire at the end of last year were ratified over the holidays (SEIU, AFSCME and MNA). New language in contracts for the next 3 years.

Board Reappointments are coming up as well at the end of March. More on this at our next meeting.

Emergency Declaration has been extended so there will not be Medicaid drop-offs either (resulting in very stable Medicaid funding for rest of fiscal year).

Sandy has written a letter to Ken Horn about this topic that she plans to send once the vote has been officially scheduled. She wants it to be the last voice he hears on this topic. Sandy will keep the CAC apprised on any news on the topic.
