# VI. CEO REPORT – SANDRA LINDSEY

Sandy reported that MDHHS and Actuary (Milliman) is requiring CMHs and Providers provide a salary wage survey which is going on now. This is without a doubt a heavy lift especially those of smaller size. Questions can be directed to the MDHHS.

Applications for Provider Staffing Stabilizations Programs are to be going out shortly. Applications must be submitted to CMHSPs for additional payment from MSHN. Some CMHs in the region do not have financial savings and that is why this is being announced. SCCMHA finds ourselves in a favorable position so we have been doing so already to our providers.

40 staff members that work at Covenant / SCCMHA Crisis Center are impacted by CMS COVID-19 vaccination mandate (12-14 sites in county). We have recently attested to Covenant that all these folks have done so or provided

#### SB 597 & 598

These bills were supposed to be brought up for vote this week but did not occur (there was instead a third reading and there were not enough votes). 38 Michigan senators and 22 are republicans so we're looking for senators not to vote for this piece of

legislation. There is a lot of activity in this area. Democrats in the Senate have all gone on the record saying they are not going to vote for this. Phone call with colleagues today and talked about current events. Sandy sent a letter to Sen. Ken Horn on this topic and spoke to his office this week as well. His office has made it clear that he intends to support these bills unfortunately. If senate votes them out to Senate it would then move to Michigan House. It is believed that this would not be taken up for action very quickly in the House and likely to be later in summer perhaps. Rep. Amos O'Neal has gone on record as saying he will not be voting for SB 597/598. It is unknown how Congressman Wakefield is leaning.

Learned today that State of Michigan MDHHS is reorganizing departments. Slide deck will be out tomorrow hopefully. Major changes were discussed today. 100 people participating. BHDDA is being dissolved and responsibilities will be given to another department. Question was asked, is this related to SB 597 / 598? Told it was not. Sandy and her staff will be giving this info a better read once the PowerPoint is released. Build capacity for Mental Health Services was the reasoning.

Page 29 includes the advocacy efforts from CMHA. 2/3 of Michigan voters do not support SB 597 & 598.
