I. OPENING PROCEDURE

IV. OTHER ITEMS OF IMPORTANCE

Sandy noted that she had a really productive conversation with Great Lakes Bay Health Centers today. GLBHC is building the new site on Court Street at former Moore Elementary. Kristie and Sandy are working with them in particular on referrals for families (by way of pediatricians to CMH). We're currently developing the strategies. This conversation started before COVID-19 and SCCMHA is happy to be picking this back up.

Sandy talked a bit about CCBHC and SUD services as well. We have had positions posted for a really long time and they remain vacant. We will be looking at potentially expanding our telehealth contract for short term therapy from Master's prepared clinicians for persons with mild/moderate conditions under CCBHC.

Sandy reported there is no new news on Senate Bills B 297 and 298 and they still have not been brought to a vote.

Last week, the federal government announced an extension of the COVID-19 public health emergency (PHE) for an additional 90 days. Effective July 15, 2022, this 90-day extension marks the continuation of several temporary authorities afforded under the PHE, including continuous eligibility requirements, waivers of telehealth restrictions, and federal medical assistance percentage (FMAP) increases, among other items.
