About This Training

The goal of Mental Health First Aid is to teach methods of assisting someone who may be in the early stages of developing a mental health problem or in a mental health crisis and provides useful information on how to assist a person who has a history of a mental health disorder or longer-term mental health problems.

Learning Objectives

Through participation, trainees will be able to meet the following objectives:

- 1. Define and explain mental health and the impact of mental health disorders; Evaluate the spectrum of interventions for mental health problems and evaluate the list of resources for persons with mental health disorders.
- 2. Memorize the Mental Health First Aid Action Plan.
- 3. Recognize the definition of depression and other mood disorders.
- 4. Express helpful resources for depression, suicidal intentions and non-suicidal self-injury.
- 5. Identify/define anxiety disorders and the types of anxiety disorders; Express helpful resources for anxiety disorders.
- 6. Define psychosis and identify the causes; List the types of disorders and helpful resources in which psychosis can occur.
- 7. Define substance use disorders and evaluate the cause of substance use disorders.
- 8. Summarize the importance of early intervention for: depression, anxiety disorders, psychosis, and substance use disorders.
- 9. Memorize the Mental Health First Aid Action Plan for: depression, anxiety disorders, psychosis, and substance use disorders.
