# VI. CEO REPORT

The new 1915 ISPA Medicaid Waiver is front and center as we end the fiscal year. This is a new Medicaid Waiver replacing much of what was in the B3 Medicaid Waiver. Network wide SCCMHA has approximately 1,500 consumers that will need to be individually enrolled on this waiver in FY 2023 and then annually redetermined for service eligibility. Consumers being enrolled are those receiving select services like Community Living Supports, Skill Building, Respite, Supported Employment, Enhanced Pharmacy, Housing Assistance, and others.

SCCMHA Made decisions today about network providers that will be extended Designated Community Organization (DCO) status for Medicaid and uninsured persons under the CCBHC-Demo in 2023. These arrangements will greatly expand CCBHC enrollment next year and include all currently contracted clinical teams at TTI, Hope Network, Saginaw Psychological Services, Westlund Guidance and 1-2 MSHN SUD providers.

Sandy indicated that the Governance Committee meeting this week needs to be potentially cancelled for Thursday. Ryan has some family health circumstances he needs to address down state and we have no one available to replace him and Sandy also has another meeting at same time. Governance Chair agreed to cancel the meeting.
