#### VIII. CEO REPORT – SANDRA LINDSEY

Sandy noted SCCMHA is working on a new brochure for SCCMHA services. We continue to make headway but it has taken us several years to get this moving again with everything going on.

Demand for mental health services continues to be very high. Getting between 110-150 new consumers requesting services monthly. Workforce shortages have had an impact, but we continue to do the very best we can. Crisis Center continues to be busy as well. Sandy is working with SOM about volume of adolescents that are presenting at Emergency Department. Hopeful to find some sort of remedy for Child Caring Institutions (they did not receive any sort of wage increase passthrough as the rest of us did). 35 individuals presented in February. Attempting to divert from emergency departments.

Sandy is meeting with MDHHS officials with Michigan Hospitals, their association regarding facilities losing money because patients are experiencing long waits for state hospital placements (Sandy is serving as a key informant to this group). State is attempting to do some reorganization in this area, but movement of new money has been very difficult. On Medicaid side, SOM is doing as much as it can with such expenses.

Completed 22-page Rand Corporation (SAMHSA contractor) for CCBHC Demonstration sites. Very technical.

Staff recruitment is going well in some areas but off some in others. Our network is no different. Staffing of drivers and direct care staff for CTN/CTS are really difficult at present to fill these very necessary positions. Sadly there is not likely not to be major change in this in near future.

Sandy was asked to give testimony on realities of what it is like to be a CMH director (operational challenges on the ground, ideas for appropriations for FY 24, list areas we would like to consideration for funding---estimated that \$4 more for direct care to be able to compete, more GF funding as redeterminations of Medicaid eligibilities are set to begin again with ending of Federal Health Emergency). No one has been discharged from Medicaid / Healthy Michigan since the being of COVID-19 Pandemic. Spenddowns will also go back into effect and GF funding has been used in past in support of these folks. Individuals that have moved and not updated their addresses are of particular concern to Medicaid Eligibles. Recommended that we all speak of this in each of our own spheres of influence.

No change in local hospital psychiatric beds in SOM and there is still and estimated Waiting list of over 300 people waiting for state facility placements.

Women of Colors is submitting grant to Health Endowment Fund for implementation opportunities for persons of color and healthcare access. SCCMHA is helping them with this 2-year grant (imbed additional peers here at SCCMHA and also peer recovery

coaches). Letter of Support has been written but the submission is later on this year. A lot of work but this is going well.
