VI. CEO REPORT – SANDRA LINDSEY

Sandy noted that we will have three (3) SCCMHA Board vacancies coming up at the end of this year. She will be reaching out to Board Chair, Christopher Boyd at the Commission (K. Schachman, D. Nagel and C. Long). We have some leads that we are hoping to reach out. Appointments are all made ultimately by Saginaw County Board of Commissioners. She will also solicit some members for CAC participation as well.

Election is over and Sandy is tracking who has been elected recently. Unsure on how this will impact CMHs like SCCMHA. There is some work going on in lame duck (CCBHC financing, etc.).

In 2025, SCCMHA and our partners will be working collaboratively to redue the <u>Saginaw County First Responder's Guide for Behavioral Interventions</u> as it has been a while since it was last updated.

Kristen McDonald Rivet won the US Congressional seat so there will be a vacancy for her position in Michigan Senate. We'll see about the Governor's appointment for her vacant seat.

SCCMHA Diversity, Equity, Inclusion (DEI) work continues. We're about to complete a report by the beginning of the year. We will then begin our next 3 year plan.

Disability Network has decided to notify of ending their contract (60 day notice) with SCCMHA for Support Coordination. We will be working to add staff hopefully upcoming.

Construction going on at Hancock at moment. On second floor the Community Support Services suite is being renovated. Staff have been moved to the Hancock first floor and lower level during this work. Looking forward to Spring 2025 completion date.

Genoa Pharmacy's 20th Anniversary Celebration is coming up on December 5th.

Sandy noted that she is negotiating her final SCCMHA contract and has begun with working with Board on this in December. Her official date for retirement has not yet been decided.

Reminder that the combined Board / CAC Holiday Meeting is coming up on Monday, December 9th at 5:30 PM.

All SCCMHA's Union Contracts expire at the end of this year. Negotiations are going on now through the end of this year.
