Sandy briefly spoke on MDDHHS decision to implement conflict free assessment and planning by Oct. 1.

State also has a settlement agreement for Waskul lawsuit (related to support for people enrolled in HABW and Self Determination services). Impact roughly 35 folks in Saginaw Co. As part of settlement, staff for HABW in SD will be paid \$31.00. Result in additional \$1.2M more for 35 people in Saginaw. We have until July 15 to note your objection to this settlement. The fear is that this will destabilize the residential network.

Sandy noted SCCMHA has successful submitted documentation for CCBHC Recertification before June 3 deadline.
