## **VIII. OTHER ITEMS OF IMPORTANCE**

Sandy noted that SCCMHA Board received info about the Stand Up for Medicaid townhall on May 6<sup>th</sup> at SVSU's Curtiss Hall from 6:00 – 8:00 PM. Doors open at 5:30 PM. Come and hear about \$880 Billion proposed federal Medicaid Cuts (\$16B for Michigan). 71% of Michigan Medicaid dollars come from federal money. Impacts on standard Medicaid, TANF, Blind and Disabled and Healthy Michigan Beneficiaries. Currently over 67,000 Medicaid enrolled individuals in Saginaw. Medicaid expansion (i.e. Health Michigan cuts are a really big concern as federal funding match is 90 %). Stakes could not be higher.

Sponsors of event are Indivisible Chapters in Chesaning & Midland and W.O.M.E.N.

Results of event are going to be shared with local elected officials. Sandy is working with partners on planning.
