- SCCMHA continues to look for therapist to serve mild/moderate population in CCBHC (currently working with two telemedicine providers.
- Credentialing / Licensing has been of particular concern but should have two starting later in in May/June (approximately 60 hours per week) which is really good news.
- TBD Solutions is working on a data dashboard for us. We see this as a way for clinicians to see movement of consumers to/from care (should put some additional tools at their disposal). TBD is very close to completion.
- Kristie is hopeful SCCMHA is able to ramp up CCBHC services and enrollment yet this summer.
