SCCMHA Certification by MDHHS as CMHSP

MDHHS recertifies all CMHSPs in Michigan every three years to be sure they meet all the standards in the Michigan Mental Health Code, under the Administrative Rule 330.2801 for Community Mental Health Service Programs (CMHSP). Our recertification process began a couple of months ago. This involves the submitting of SCCMHA policies, procedures reports and other documented evidence that we meet all the required standards for CMHSPs.

The Michigan Department of Health and Human Services, Division of Contracts and Quality Management has reviewed the SCCMHA CMHSP certification renewal application and related documents we submitted a couple of months ago. On February 22, 2024, we received a letter from MDHHS indicating that our application and the voluminous supporting documentation that we submitted into the MDHHS CRM Portal, were determined to be adequate for recertification. Related but separate from this activity, but required for full CMHSP Certification, is the audit of our Office of Recipient Rights which will be scheduled by MDHHS ORR sometime next year.
